

# 2025 Photo Competition

### Promoter

1. Sunwater Limited (ACN 131 034 985) of Green Square North, Level 9, 515 St Pauls Terrace, Fortitude Valley Qld 4006 (**Sunwater**) is conducting this competition.

## **Eligibility Criteria**

- 2. Entry to this competition is open to people who are:
  - (a) are aged 18 years or older;
  - (b) not currently an employee of Sunwater or one of Sunwater's related entities; and
  - (c) reside in Queensland, Australia as their primary place of residence.
- 3. Any photograph(s) which are submitted by a person as part of this competition must be:
  - (a) 100% photographic in origin and taken in landscape orientation;
  - (b) the original work of the person who is entering this competition, and not generated or created by artificial intelligence using image-creation software;
  - (c) submitted to Sunwater in a JPG file which retains the original metadata of the photo (including the location of where the image was taken) and be a minimum file size of 24MB (or 300 dots per inch);
  - (d) entirely taken by a mobile phone, digital camera and/or drones (as permitted by law) in designated public access areas around Sunwater owned and/or operated infrastructure;
  - (e) of authentic Sunwater infrastructure and its surrounding natural landscape including but not limited to dams, lakes, weirs, barrages, irrigation channels, pipelines or pumps; and
  - (f) not depicting any:
    - i. nudity
    - ii. illegal activity or dangerous behaviour;
    - iii. watermarks or other branding; or
    - iv. faces of person(s).
- 4. There is no limit to the number of entries a person may submit. A maximum of three photographs may be submitted with each individual entry form that is submitted.
- 5. Entries must be submitted via online entry only. To enter this competition, you must fill out the entry form available at www.sunwater.com.au/community/photography-competition. Entrants will be asked for their details, photo location details, a short safety message relating to the photograph, and a high-quality image copy of the photograph(s) which complies with all requirements outlined in clause 3 of these terms and conditions.
- 6. Entries open at 12:01am AEST on 30 March 2025 and close at 11:59pm AEST on 30 June 2025.

#### Judging Entries and Prizes

7. Each entry to this competition will be judged by a panel consisting of judges selected by Sunwater in its absolute discretion. The decision of the judging panel is final.

- 8. Entries will be judged based on the following criteria:
  - (a) creativity;
  - (b) composition and
  - (c) aesthetics.
- 9. Thirteen winners of this competition will be selected by the judging panel using the criteria contained in clause 8 of these terms and conditions. The winners will receive the following prizes (with the first placed winner receiving the first prize and the other additional twelve winners each individually receiving the second prize):
  - (a) first prize: 1 x \$500 gift voucher issued by a business of their choice as listed in **Schedule 1** of these terms and conditions; and
  - (b) second prize: 1 x \$250 gift voucher issued by a business of their choice as listed in **Schedule 1** of these terms and conditions,

(each a **Prize** and collectively the **Prizes**).

- 10. Each entrant may win up to a maximum of 2 Prizes irrespective of the number of submissions which they make to this competition.
- 11. This competition is a competition of skill. Chance plays no part in determining the winners.

#### General Terms and Conditions

- 12. By entering this competition, each entrant agrees to be bound by these terms and conditions.
- 13. Sunwater may in its absolute discretion refuse to award any of the Prizes or disqualify any entrant who fails to comply or is reasonably suspected by Sunwater of having failed to comply with any of these terms and conditions.
- 14. Any entries received after the closing time will be deemed invalid. Sunwater accepts no responsibility for late, lost, delayed, illegible, corrupted or misdirected entries.
- 15. By submitting an entry to this competition, the entrant:
  - (a) warrants that they own all intellectual property rights (including copyright) in each photograph(s) and safety messaging submitted for the purposes of this competition;
  - (b) grants Sunwater an irrevocable, unconditional, perpetual, royalty-free, non-exclusive, worldwide, transferable and sublicensable license to use, publish, display, communicate, distribute, print, develop or modify the photograph(s) and safety messaging and the intellectual property rights which are contained in the photograph(s) and safety messaging for any purpose, including without limitation commercial purposes;
  - (c) consents to Sunwater engaging in any actions or omissions which may infringe on the entrant's moral rights as defined in the *Copyright Act 1968* (Cth) in relation to their photograph(s) and safety messaging for the term of the intellectual property licence granted under clause 15(b);

- (d) agrees to Sunwater:
  - retaining or storing the photograph(s) in hard copy or digitally, including but not limited to, deposit of the photograph(s) into Sunwater's multimedia library, and using the photograph(s) for the creation of a physical Sunwater branded calendar and for another other purpose as Sunwater sees fit; and
  - ii. tagging them in any posts made by Sunwater on any social media platforms for the purpose of promoting this competition;
  - iii. publishing or disclosing their name, if Sunwater choses to do so, as an entrant and/or winner in this competition, whether or not in connection with the photograph(s) they have submitted; and
  - iv. combining photograph(s) submitted by entrants with alternate safety messaging that has been submitted by other entrants, if required, to avoid similarity of featured messaging on the Sunwater branded calendar.
- (e) acknowledges and agrees that they must when taking photograph(s) that will be submitted as part of this competition:
  - i. comply with all laws;
  - ii. not trespass on any land or property;
  - iii. not cause any damage or loss to tangible property (including third party property);
  - iv. not engage in any conduct, actions or omissions which may result in injury, death or illness to themselves or any other person; and
  - v. not create any nuisance to other person(s).
- 16. Each entrant agrees for Sunwater to collect, use and store their personal information to communicate with them about Sunwater's products, the Prizes, services and information to them, its customers, for its business operations, to use, copy or reproduce the photograph(s) for any purpose, to market this competition on social media platforms, and to comply with the law. Sunwater's Privacy Policy (which includes Sunwater's Credit Reporting Policy) can be viewed at <u>www.sunwater.com.au</u> and tells entrants how Sunwater usually collects, uses and discloses personal information, credit information and credit eligibility information and how a person can ask for access to it or seek correction of it. Sunwater's Privacy Policy also contains information about how entrants can make a complaint and how Sunwater will deal with such a complaint. By entering this draw the entrant consents to their personal information being collected, used and disclosed by Sunwater in accordance with Sunwater's Privacy Policy.
- 17. To the extent permitted by law:
  - (a) Sunwater's total and maximum liability to the entrant(s) arising as a result of or in connection with this competition is limited to the re-supply or replacement of the Prizes; and
  - (b) Sunwater shall not be liable for any loss, damage or injury suffered or sustained by any person (even if caused by negligence) as a result of or in connection to this competition. This includes

but is not limited to accepting, possessing, using or misusing the Prizes, including any goods or services received as a consequence of using or misusing the Prizes.

- 18. Each entrant agrees to indemnify Sunwater on demand against all claims directly or indirectly incurred or suffered by Sunwater in respect of:
  - (a) any infringement by the entrant of any intellectual property rights of any other person in respect of any photograph(s) and safety messaging entered into this competition;
  - (b) the entrant's failure to comply with clause 15(e); and
  - (c) the use of the photograph(s) and safety messaging by Sunwater.
- 19. Sunwater does not accept any liability for the Prizes not being used by the prize winners within any prescribed period which may be identified on the Prizes or advised by an issuer of the Prizes.
- 20. Winners will be selected no later than 1 week after the closing date for entries into this competition.
- 21. Sunwater will contact each winner by email and/or telephone within 7 days of being selected by the panel of judges. Each winner must within 7 days of being notified as a winner by Sunwater nominate to Sunwater a business listed in **Schedule 1** of these terms and conditions to issue the Prize.
- 22. Where Sunwater is unable to contact a winner within 7 days of being selected or where a winner does not nominate the business which will issue the Prize in accordance with clause 21, Sunwater will select another winner in place of the winner in accordance with clause 8 above.
- 23. The Prize is non-transferable. If a business which a winner selects from **Schedule 1** is unable to issue the Prize for reasons beyond Sunwater's control, Sunwater may substitute the Prize with one of equal or greater value procured from an alternate business also identified in **Schedule 1**.
- 24. The Prize will be delivered by Sunwater to the prize winner no later than 6 weeks after the prize winner has selected their preferred Prize issuer in accordance with clause 21 (or such reasonable longer period where Sunwater is delayed in obtaining the winner's address for delivery due to reasons beyond its control or as otherwise agreed between Sunwater and the prize winner).
